## PURPOSE:

To request Governing Board approval for 2016-2017 funding contribution of \$670,851.00 to the Arizona Department of Economic Security/Rehabilitation Services Administration for the Transition from School to Work (TSW) program

## **DESCRIPTION AND JUSTIFICATION:**

The annual funding contribution is part of a collaborative Intergovernmental Agreement approved in June 2015. Tucson Unified School District's funding contribution is used by Rehabilitation Services Administration/Vocational Rehabilitation (RSA/VR) to capture federal money which is then used to repay TUSD's funding contribution, plus all other TUSD expenses (instructional staff salaries, benefits, equipment, supplies and professional development) associated with the Transition from School to Work (TSW) program budget.

As per the agreement the Arizona Department of Economic Security, Rehabilitation Services Administration/Vocational Rehabilitation (RSA/VR), will provide TUSD students with enhanced transition through the Transition from School to Work (TSW) program. Enhanced transition services will include the referrals of students to RSA/VR Counselors, career exploration, job training, and vocational preparation.

Schools will include Cholla Magnet High School, Mary Meredith K-12, Pueblo Magnet High School, Sahuaro High School, Tucson High Magnet School, and Exceptional Educations's ACT Program. Services will include enhanced transition/vocational preparation for high school students with disabilities.

Maura Clark-Ingle, Director of Exceptional Education, and Dan Perino, TSW District Coordinator, will be present to address questions.
