COST SHARED TUCSON PD SCHOOL RESOURCE OFFICERS

- Reduced from 6 in SY 17-18 to 5 in SY 18-19.
- Pueblo HS is ADE Grant Funded for SY 18-19 and was cost shared last year.
- This year for same sites, Booth-Fickett, Catalina. Cholla, Palo Verde and Santa Rita.
- Pueblo, Tucson and Utterback are 100% grant funded

DUTIES OF COST SHARED SRO

- To work with Principals and/or Principal's Designee to develop procedures for ongoing communication to ensure timely and uniform reporting of criminal activities.
- To serve as a member of the School Safety Assessment and Prevention Team.
- To utilize expertise and agency resources for intervention and prevention of potential crime.
- To collaborate with school personnel on school-wide safety strategies (e.g. staff trainings, emergency response planning, needs assessment, and prevention programming. (active shooter training this coming year)
- To build relationships with students, parents and staff that promote a positive image of law enforcement.
- To provide a minimum of 140 hours of Law-Related Education (LRE) per year in a format and amount of time mutually determined by the parties which may possibly include universal classroom instruction, classroom instruction to ongoing cohort groups of students, instruction to school staff and school community, planning.
- To serve as a positive role model for students, administrators and the school community.

- Summer Youth Program under development to provide leadership and teambuilding skills and improve police community relations. (for youth ages 6-14, with HS students selected to help run the program.)
- Department Immigration Policy Specific to SRO's (General Orders Chapter 2300 – Section 2337)

COST OF THE PROGRAM

- TUSD shall reimburse TPD for payment of one-half (1/2) of a single SRO base salary plus Employee Related Expenditures for the 2018-2019 school year.
- An SRO's base salary plus Employee Related Expenses for the 2018-2019 school year is estimated to be approximately \$97,458 in total which means that TUSD will be responsible to reimburse TPD for only one-half (1/2) of that sum or approximately \$48,729 for each of the five (5) SROs assigned to TUSD schools.
- Total estimated costs is \$243,645
