PURPOSE:

Permission to accept the Terms & Agreement of the Arizona School Facilities Board for the Building Renewal Grant for Tucson Unified School District (Chiller replacement at Rincon HS). Included in this approval would be permission to award a construction contract to Midstate Mechanical, a Mohave contractor, in the amount of \$353,775.00, which includes \$303,775.00 in Building Renewal Grant Funds and \$50,000.00 in Bond Funds. A project Contingency of \$21,225.00 in Building Renewal Grant Funds is also included in this award.

---

DESCRIPTION AND JUSTIFICATION:

Bonds and Architecture has worked with the School Administration and the Arizona School Facilities Board (AzSFB) to develop this grant and the related project. This project will replace two of three chillers in the Rincon/University Plant. One is currently inoperative and the second is showing signs of pending failure.

For several years, the AzSFB had not provided funds to the districts under the Building Renewal formula; however, some Building Renewal was allotted this year to fund grants for critically needed projects. This project was selected for consideration from the projects that TUSD has submitted.

The Project Manager will be Ed Lees.

This item relates to Superintendent Goal No. 1 - Student Achievement. Renovations and Upgrades to the school will support student achievement by providing an optimal physical learning environment for our students.

Marcus E. Jones, R.A., Program Manager of Bonds and Architecture, will be available to answer questions.
