

Dear Dr. Romero:

As a proud Pucblo High School alumni and member of the PHS Warrior Hall of Fame, I am very pleased to support the naming of the Warrior Football Stadium as "The Salumino "Curty" Santa Cruz Football Stadium" in honor and recognition of a most distinguished Warrior alumni. I have known Curly since our childhood as we humbly grew up together in the City of South Tucson. Living in a neighborhood known as Barrio Libre. I always remember that the students at Mission View Elementary School were keenly aware of all of his personal attributes, as well as his ever-present leadership traits. He was recognized as an accomplished athlete, and as a naturally gifted leader. Many of us carefully followed his progress throughout high school and well beyond.

As a dedicated and energetic student at Mission View, Safford Elementary, Wakefield Junior High and Pueblo High School, Curly excelled both in the classroom and on the athletic field. Since his graduation from Pueblo High School in 1962, "Curly" Santa Cruz's outstanding achievements in his pursuit of higher education established the solid foundation for his successful professional career which has resulted in noteworthy honor, merit and distinction to his alma mater, his family and his community. He earned a Bachelor of Science degree in Education in 1968, and in 1975 was awarded a Master's degree in Secondary Education from the University of Arizona.

Curly served with distinction as an educator and coach for 40 years at Tucson Unified School District, Including 39 years at his alma mater Pueblo High School. As an award-winning teacher, coach, department coordinator and athletic director, his locus was always on being a great mentor and role-model to each of his students and athletes. A true example of his community leadership became evident when the school district required students to pay a \$105 sports participation fee, which many of their families were unable to afford. Curly quickly organized a fundraising drive which successfully enabled 137 students and their parents to only have to raise \$25 to meet the previously established fee.

Throughout his professional career in the field of education and sports, countless students and athletos have benefited from his extraordinary talents and knowledge. Curly has coached championship teams in both football and track, and in the process has won numerous "Coach of the Year" and "Teacher of the Year" from such groups as the Hispanic Sports and Academic Enrichment Program, NOSOTROS, and the Tucson Conquistadores. In 1988, he was named "Coach of the Year" by the Arizona Daily Star and the Tucson Citizen, which was significant since this was the only season that a Pueblo football team enjoyed an unbeaten season. For four years, he was named an Arizona All-Star Coach, and in 1992 was voted as the Arizona All-Star Head Football Coach for the Arizona All-Star game.

For his exemplary leadership and accomplishments, Coach Santa Cruz has been the recipient of numerous prestigious awards and honors. In 2011, he was awarded the Signature Coach Award which is presented to a coach who best demonstrates the ideals of coaching and who has contributed to the success and quality of life for students and their surrounding community. In 2012, he was inducted into the Pima County Sports Hall of Fame for his many accomplishments as a player and coach. In 2015, I was honored to nominate Curly for the League of United Letin American Citizens (LULAC) National Presidential Citation and Community Service Award, which is their highest national award, and I was even prouder to have been asked to present him with this distinguished award at their annual educator's banquet which was attended by more than 600 people.

Coach Senta Cruz is truly a man of vision and purpose, who even in his retirement has not forgotten his true calling of mentoring students in a wide variety of ways. Shortly after his retirement, he established a mentoring program for Warrior students and provided them with support for academic achievement, personal goal setting and in the critical area of social/personal development. For many years, he has served as the Co-Chair of Si Se Puede Day which annually brings back alumni to speak to students and share with them their experiences in achieving personal and professional success. In 2014, I was honored to join with him and fellow alumni Richard Gastellum in making a presentation which ultimately resulted in the award of first-place in a statewide competition for \$15,000 in the Bookman's School Challenge which assisted in funding computers for the newly established PHS Cyber Cafe.

Throughout the years, Curly has effectively demonstrated qualities of good character, solid judgement and exceptional achievement that have resulted in bringing significant recognition, honor and distinction to his alma mater, his family and his community. As a result of this, it is for his untiring efforts in serving the educational and athletic needs of our students and youth for so many years, that I strongly recommend and endorse the naming of the Warrior Football Stadium as "The Saturnino "Curly" Sante Crux Football Stadium."

Saturnino "Curly" Santa Cruz

The following is a more complete listing of Mr. Santa Cruz's accomplishments and achievements:

- In 2015, Mr. Santa Cruz was the recipient of the National LULAC Presidential Citation Educational Leadership Award, which is their highest national award. He was recognized for his years of outstanding contribution, service, and leadership within the educational community, especially as it relates to serving the youth of our community.
- In 2012, he was inducted into the Pima County Sports Hall of Fame in honor of those
 who have brought lasting fame and recognition to the Pima County Sports Community
 and in 2011 he was awarded the annual High School "Signature Coach" Award given to a
 coach who demonstrates the true ideals of the coaching profession by providing
 outstanding leadership and service to education, today's youth and to their community.
- In 1990, be was the recipient of the Tucson Conquistadores "Outstanding Achievement Award," As a result of budget constraints following the rejection of two budget overrides, the Tucson Unified School District School Board increased activity fee from \$10 to \$105. The \$105 fee was unattainable for Pueblo families and it would have eliminated the entire Pueblo football program. Under the leadership of Coach Santa Cruz, the football team members fundraised over \$10,500 in two months to help pay the participation fee for about 125 players. The football program paid \$80 for each student athlete and each parent paid the remaining \$25 for their child.
- In 1992 he was presented the NOSOTROS "Community Service Award" for his service
 and leadership contributing to the quality of life for his community. He has won
 numerous "Teacher of the Year" awards and "Coach of the Year" honors.
- In 1998 he was named "Coach of the Year" by the Tueson Citizen and Arizona Daily Star
 for coaching the only season unbeaten Pueblo football team in the school's history. For
 four years he was named an Arizona All-Star Coach and in 1992 was voted as the
 Arizona all-Star Head Pootball Coach for the Arizona All-Star Game.

In his tenure as a devoted educator, Mr. Santa Cruz has always worked tirelessly to improve the educational experience of all students.

- In the years 1972 to 1975, Mr. Santa Cruz and Pueblo High School counselors Estrella Gonzalez, Rosela Velez and Nino Santa Cruz, organized educational and cultural forums for the Pueblo students in week-long series of classroom presentations by prominent educators such as Dr. Lupe Castillo, Dr. Nelva Chavez, Dr. Miguel Palacios, Dr. Rachel Goldsmith and others. Presentations focused on positive discussions on education, personal and social identity, culture, history and issues affecting the community. The main focus of this event was to inspire and motivate our students and to give them a better understanding of their past history and future challenges. This educational event served as a precedent to our current Si Se Puede Day.
- In 1977 to 1980, Mr. Sante Cruz served as Senior Class Sponsor, involved in organizing and coordinating all senior class activities, i.e., school proms and graduation ceremonics.

After retirement, Mr. Santa Cruz continued to exhibit exceptional dedication and contributions for the betterment of his students.

- From 2008 to 2012, he established a mentoring program for Pueblo students. Mentoring sessions were conducted during the advisory period and were one on one or in small groups (20 students) between mentor and students who may need support for academic achievement, social or personal development and career goals. Services were offered on a volunteer basis. All of his mentees completed their high school education and a majority continued their education and earned college degrees.
- Since the 1980s to present, Mr. Santa Cruz has served on the Si Se Puede Committee, planning and organizing Se Se Puede Day at Pueblo High School and also served as a guest speaker.
- In 2011, he was inducted into the Pueblo Wall of Fame honoring individuals who have made notable contributions to Pueblo High School, to community and their chosen profession.
- In 2014-15, he was one of the co-founders of the Pueblo Warrior Foundation Hall of Fame and has served as Chair and Vice-Chair. The Pueblo Hall of Fame was established to recognize and honor Pueblo alumni who, through their exceptional achievement, contribution and service have honor and distinction to their chosen profession, Pueblo High School and the community.
- In the year 2016, he was inducted into the Pueblo High School Foundation Hall of Fame for outstanding accomplishments and contribution to Pueblo High School and our community.
- After retirement, Mr. Santa Cruz has made numerous presentations to student-parent groups for the Pueblo Science Club, Pueblo Senior Graduation Luncheon, and the Pueblo Football parents and players.
- In 2014, "Si Se Puede Cyber Café" was established as a result of being awarded \$15,000 in the Bookman's School Challenge, which is a statewide contest designed to highlight positive happenings at Arizona schools. Mr. Santa Cruz, Dan Eckstrom, Richard Gastellum and Pueblo students played an important role in the process.

Mr. Santa Cruz and family resided within walking distance from Pueblo High School and were active in school and community events, His wife, Amanda, and their children, are all Pueblo Alumous. Sons Cristohal and Miguel, and daughter, Sonia, are also University of Arizona graduates. Mr. Santa Cruz has served Pueblo High School and the Pueblo Community as a student, parent, resident, teacher, coach, administrator and alumnus.
