Deseg requirements not a part of discussion.

The far east side needs a self-contained GATE program in elementary/middle school, they are competing with Vail and Tanque Verde districts and could possibly keep students in TUSD if an equal program is available on the far east side.

Thank you for the well organized binders-very helpful.

We hope the Board has the integrity and moral fortitude to honor our work.

Process was beneficial "assigned areas" was a good idea.

We recommend that our work and its results be preserved and used for current and future decisions regarding school consolidation.

A group representing the desegregation project (some plaintiffs, lawyers and TUSD representatives) also did a mini-exercise. They felt that the ethnic/racial makeup of all impacted schools should be a key criterion and they rated the utilization of the school and the capacity of potential receiving schools as very important criteria.
