PURPOSE:

To provide the Board with information about the current Memorandum of Understanding between Tucson Unified School District and the National Center for Youth Law (FosterEd).

DESCRIPTION AND JUSTIFICATION:

Agreement with the National Center for Youth Law for FosterEd liaisons that will be based at Catalina and Rincon High Schools. Liaisons will mentor and provide academic support to foster students attending Catalina, Rincon, Tucson Magnet, and University High Schools.

Liaisons are grant funded by the National Center for Youth Law through the Governor's Office of Education to help prepare students for success in the workforce and community. A successful workforce and community is contingent upon the success of all K-12 students.

Challenges faced by foster students can impede success, including creating negative statistical outcomes for academic success. foster students experience higher rates of school absenteeism, disciplinary referrals, grade retentions, drop-out rates, low academic outcomes, and are less likely to attend a four-year college. FosterEd liaisons will work with school faculties and staffs to enhance their support of foster students, reinforcing a school culture and community striving to overcome the challenges faced by foster students, and decreasing the negative outcomes associated with their academic and lifelong success.
