ACTION ITEMS

 Declaration of Tucson Unified School District Curricular & Instructional Alignment to the Arizona Academic Standards for the 2013-2014 School Year Kristel Foster moved approval; Michael Hicks seconded. Approved unanimously in a voice vote.

Standards, still printed on the document even though the name has been changed to Arizona College and Career Standards, and we will make sure that materials, professional development and training are all aligned to the Arizona College and Career Standards, and it's a standard document.

2. Tucson Unified School District FY 2012-2013
Annual Financial Report

Dr. Sanchez explained this report is for the budget which the Board approved for the 2012-2013 year, has been used and audited, and represents information the Board has received numerous times previously. This action approves the submission to the Arizona Department of Education by October 15th in accordance with the requirement of A.R.S. §15-904.

Mr. Hicks congratulated Yousef Awwad and staff on achieving the certificate for excellence in financial reporting.

In response to Ms. Grijalva's question concerning the amount being carried forward, Yousef Awwad reported the most that can be carried forward is 4%, which would be about \$10m, but that the amount being carried forward by TUSD is only about \$1m for this fiscal year. Dr. Sanchez provided further information on potential means to be employed in a multi-tiered targeted manner designed to free up M&O funds to increase savings.

3. 2014 Arizona School Boards Association Officer Nominations

Ms. Foster reported on her attendance at ASBA meetings, and although she was not nominating anyone or herself, she expressed hope it would be considered in the future as important for the second largest district in the state to be represented in Association leadership.

Michael Hicks moved approval; Kristel Foster seconded. Approved unanimously in a voice vote.

Based on a meeting he attended with Ms. Foster, Mr. Juárez expressed his opinion that TUSD needs to be part of the discussion that involves other districts.

Ms. Grijalva stated it is important to remember that TUSD is a minority district and its needs are often different than those represented at meetings of ASBA.

In response to Mr. Juárez' question on who can attend ASBA meetings, Ms. Grijalva clarified that all events are open to members.

Dr. Sanchez indicated that benefits provided by ASBA in connecting with other districts and representing the uniqueness of TUSD would be appropriate discussions for the Board Retreat.
