PURPOSE:

To request TUSD Governing Board approval of Arizona Continuous Improvement Plans for letter grades "D" and "F" Schools per A.R.S. 15-241.

DESCRIPTION AND JUSTIFICATION:

Under Arizona state law, 15-241, schools labeled letter grades "D" and "F" are required to develop a Continuous Improvement Plan (CIP) to be approved by the TUSD Governing Board. The CIP must be submitted via the Arizona Department of Education (ADE) Arizona Local Education Agency Tracker (ALEAT).
