PURPOSE:

To schedule Special Meetings and Public Hearings of the Governing Board related to approval of the School Master Plan and initiating consolidations of schools; receiving public comment on consolidations; and taking final action on consolidations.

DESCRIPTION AND JUSTIFICATION:

In with A.R.S. 15-341(A)(33) (copy attached), once the Governing Board votes to initiate closing or consolidating schools, a public hearing must be scheduled to receive public comments on the closures/consolidations, after which the Governing Board must take action on the proposed closures/consolidations.

Attached is a Potential Schedule for Board Meetings and Public Hearings in accordance with the timelines outlined in the statute in order for the action on closures/consolidations to be accomplished in December 2012.

For action delayed beyond 2012, the statute requires that persons affected by proposed closures/consolidations receive notice at least ten days prior to a public hearing, and any vote on closures/consolidations may not take place less than ten days subsequent to the public hearing.
