Dr. Bloomfield could you please come up along with Dr. Joan Ashcraft, Director of Opening Minds Through the Arts and any other OMA staff or supporters?

Here are a few stats for you about Dr. Bloomfield's volunteer work with Tucson Unified School District.

He has volunteered in TUSD's Instrumental Repair Shop for **17 years**, often giving 3 hours 5 days a week to the Instrumental Repair Shop.

He repairs approximately 100 orchestral instruments a year.

17,000 total!

This includes setting up the stringed instruments, repairing cracks, gluing necks into position so they are in good condition for students to play.

Dr. Bloomfield raised more than \$31,000 through personal outreach to his friends and community for instrumental supplies during the **2013-14** school year.

His three children attended TUSD schools.

He plays violin and viola, performing for many years in orchestras and chamber groups throughout the community.

Dr. Ashcraft tells us, "As a talented violinist and violist himself, Dr. Bloomfield knows the intrinsic value of musical experiences for the complete education of a child. His daily commitment to Fine Arts demonstrates his personal belief in the power of music to enrich lives. Our gratitude cannot be fully expressed. We think of him every time we hear our students perform on an instrument he has repaired."

Board Meeting Report on Interscholastics

Next I'd like to introduce Mr. Herman House, Director of Interscholastics, with an update on athletics.

Mr House:

1. History- How We Got Here

In the spring of 2015, The AIA was operating as more of a business-focused organization than a membership-driven organization. Member schools began to feel left out of decisions that were affecting them financially, and the scheduling process had become unbalanced competitively. Through computerized scheduling and the formation of Divisions and Sections, schools were bound by their schedules without regard to financial impact, loss of class time or competitive balance.

Also in the spring of 2015, a decision by the Executive Board to name a replacement for the current Executive Director when his contract was completed was more than the membership could bear. The replacement was the person the membership believed was mostly responsible for the business model that was creating the aforementioned issues. As well, there was no competitive process or membership input on this very important decision. As a result, the member schools began a campaign to have the AIA change its course and return to the membership-driven organization that it was created to be or the member schools would form a new interscholastic organization to sanctioned athletics in Arizona.

All of the large school districts, including TUSD signed on to this campaign. The AIA listened. The Associate Executive Director resigned (The person slated to replace current Ex Dir.) and the process began that brought everyone to the table to discuss the future direction of the organization. From late spring throughout the summer meetings were held to revise the AIA Bylaws that would lend itself to more of a membership driven organization and set in motion a new structure for the AIA.

2. Results of the Legislative Council (Slide #1)

In September, an emergency Legislative Council Meeting was held, and the revisions to the AIA Bylaws were voted upon. Many were overwhelmingly approved by the membership. There are 45 members of the Legislative Council representing 286 high schools. Nine of the Legislative Council members represent the Arizona School Board Association. The most critical vote was to return to Conferences and Regions for competitive purposes to replace the divisions and sections, to create membership input and to create schedules that would best serve the membership. Currently the Conferences and regions are only used for legislative purposes.

3. Conference/ Region Development (Slides #2 & 3)

As a result of the Legislative Council vote and the Change of the Bylaws to return to Conferences and Regions for competitive purposes, the 5A Conference and the 4A conferences, which most of the Southern Arizona Schools belongs, scheduled meetings to develop the newly formed 6A conference. This conference will be comprised of the largest schools in the state. TUSD has two schools slated for the 6A; Tucson High Magnet School and Rincon/University High School. The charge for the regions was to work with member schools to accommodate their needs within the framework which was approved during Legislative Council.

TUSD expressed three priorities: Reduce the loss of class-time, Reduce travel, Create a Competitive balanced schedule.

4. 6A Conference Compromise with Yuma and Tucson (Slide # 4)

Southern Arizona has three schools whose enrollment placed them into the 6A Conference; THMS, Rincon/ University and Sunnyside. The prevailing thought was to appeal these schools to the 5A conference in order to prevent excessive travel. However, there were 15 other schools who appealed to move to the 5A, and many had similar concerns including the Yuma Schools. Because the Legislative Council's direction to work with each member school, the 5A and 4A conferences voted to deny 19 of the 20 appeals but vowed to address each schools concerns.

A compromise was reached with the Tucson and Yuma schools in the 6A to create sub-regions similar to the PAC 12's North and South conferences.

In this compromise, the Tucson and Yuma Schools would comprise a conference, but would play the majority of their games locally and then, based upon the competitive records, play a region championship at the end of the season to determine the automatic qualifier to the state tournament. These games would be held one year in Tucson and the other year in Yuma.

However, further discussion produced the idea that these region championship games could played at a neutral site at the halfway mark between Yuma and Tucson. further reducing travel for both Yuma and Tucson. Additionally these games could also be scheduled for a Saturday, which eliminates loss of class time for the students. The alternative would be to play in a Region comprised of Phoenix Schools, would undoubtedly be the Chandler Schools. Due to the highly competitive nature of the Chandler Schools, the conference felt that they would receive an unfair competitive advantage if allowed to operate under the compromise given to Tucson/Yuma.

That is where we stand now and the scheduling process has begun. By the end of February a full compliment of schedules will be ready for the AIA Executive Board's approval.
