PURPOSE:

Permission to proceed with a contract to Kittle Design and Construction, to relocate the central plant systems underground HVAC piping to above ground piping in the amount of \$201,709, which includes the base bid, alternate 1, 2, 3 and a 10% contingency. This permission shall include the authority, with prior approval of the Arizona State Facilities Board, to expand the contract beyond \$250,000 as required to address anticipated unknown underground conditions.

Marcus E. Jones, R.A. Program Manager, Architecture and Engineering, will be present to answer questions.

DESCRIPTION AND JUSTIFICATION:

TUSD has received a Building Renewal Grant from the State Facilities Board (SFB) in the amount of \$ 713,100 to fund Phase I and Phase II of this project.

This approval will provide the Phase II work in the amount of \$201,709. Phase II is being conducted under a separate contract from the Phase I work, and will address the underground HVAC piping relocation to above ground to facilitate accessibility in regards to maintenance and repairs.

Phase I work has completed and provided refurbishment of the two boiler units and miscellaneous reworking of existing piping in the central plant.
