## PURPOSE:

Extend the agreement for the provision of required childhood immunization services to the school children of Pima County for a period of one (1) year beginning December 15, 2012 and ending December 14, 2013.

## DESCRIPTION AND JUSTIFICATION:

Pursuant to A.R.S. 36-673(C), TUSD registered nurses may hold site-based clinics to administer immunizations to school-aged children attending District schools. TUSD School Health Services will establish Vaccine for Children Program status to provide vaccine at no charge to the district or parents of VFC eligible children under the Federal Vaccine for Children Program 9 established by the Omnibus Budget Act, Section 1928 of the Social Security Act, August 10, 1973.

Justification: To improve immunization compliance as required by law for school attendance. It has been demonstrated that compliance is enhanced by school site immunizations. School site clinics prevent suspension for non-compliance as mandated by state law.

This directly relates to the Superintendent's Goal of Achievement. Immunizations decrease the likelihood of contracting a communicable disease causing missed school days and therefore impact the achievement of students so that they can fulfill credits required to become freshmen and sophomores.
