| PURPOSE: | | | |
| This action will give the Director of Planning Services authority to execute a Lease-Purchase Agreement with Flowers and Bullets Collective for portions of the former Julia Keen Elementary School at 3538 East Ellington Place, Tucson AZ. | | | |
| DESCRIPTION AND JUSTIFICATION: | | | |
| The Flowers and Bullets Collective seeks to lease the former Julia Keen Elementary school to provide an urban farm and arts and culture site, with food production, education, health and healing, and arts and culture programs to support the community. | | | |
| The lease is for five years and may be renewed for an additional five-year term. Flowers and Bullets will accept the premises "as-is" and will pay no rent for the first year, though they will be responsible for all utilities and maintenance for the areas they occupy. In subsequent years, if they demonstrate that they have finances to support the lease, they will pay \$37,200 per year. TUSD can terminate the lease after the first year if Flowers and Bullets does not demonstrate that they have finances to support the lease. | | | |
| The lease also allows Flowers and Bullets, after demonstrating that they have sufficient financial resources, to purchase the site. At that point, during the escrow period, 50% of the rent will accrue toward the purchase. | | | |
