TITLE:	Closure of Wakefield Middle School including Recommendations for the 2013-2014 School Year for Merger with Hollinger K-8 and Van Buskirk Elementary School

PURPOSE: Provide information for the consideration of the closure of Wakefield Middle School including recommendations for the 2013-2014 school year for merger with Hollinger K-8 and Van Buskirk Elementary School.		
DESCRIPTION	AND JUSTIFICATION:	
Wakefield Middle School is a candidate for closure because it meets most of the criteria approved by the Governing Board, including low and declining enrollment, higher performing, nearby receiving schools, an annual savings of about \$700,000 and a relatively good potential for reuse. Schools in the area are at less than 70% full on the average and this change would bring them closer to the 90% optimum.		
Creating a K-8 at Hollinger helps to meet the demand for K-8 programs in the area, provides a dual language K-8 program and reduces transitions for exceptional education students. Middle School students in the area could attend Utterback or Safford which are within two and three miles.		
On the negative side, Wakefield has facilities appropriate to a middle school; these would need to be added to Hollinger.		
Vivian "Candy" Egbert and Bryant Nodine will be available to answer questions.		
This will directly affect achievement, enrollment, transportation and customer service. Thus, Superintendent's Goals 1, 2, 4, 6 and 7 are affected. This project will be coordinated to support these goals and the desegregation plan. Actual impacts, positive or negative, will be assessed as the options are evaluated.
