PURPOSE:				
Provide information for the consideration of the closure of Fort Lowell-Townsend K-8 including recommendations for the 2013-2014 school year for merger of 6-8 grades with Doolen and Magee Middle Schools, and K-5 to Whitmore Elementary School.				
DESCRIPTION A	AND JUSTIFICATION:			
Fort Lowell - Townsend is a candidate for closure because it meets most of the criteria approved by the Governing Board, including poor academic performance, slightly higher performing receiving schools, significantly declining enrollment, a high likely value for alternative use of the site, and a high annual savings (\$820,000). There is room for additional students in the receiving middle schools.				
On the negative side, the school received the Fort Lowell students two years ago and those students still at the school would now move into other receiving schools. Also, Whitmore would be over capacity. Thus, Exceptional Education classes would need to be moved from Whitmore and/or classrooms or portables would need to be added to provide space for the new students.				
Vivian "Candy" Egbert and Bryant Nodine will be available to answer questions.				
This will directly affect achievement, enrollment, transportation and customer service. Thus, Superintendent's Goals 1, 2, 4, 6 and 7 are affected. This project will be coordinated to support these goals and the desegregation plan. Actual impacts, positive or negative, will be assessed as the options are evaluated.
