PURPOSE:

DESCRIPTION AND JUSTIFICATION:

Under Arizona state law, 15-241, schools labeled letter grade "D" are required to develop a Continuous Improvement Plan (CIP) by 11/1/2012. The CIP must be submitted via the Arizona Department of Education (ADE) Arizona Local Education Agency Tracker (ALEAT). The Governing Board is required to approve each plan within 30 days of submission.
